

# REVOCATION OF POWER OF ATTORNEY

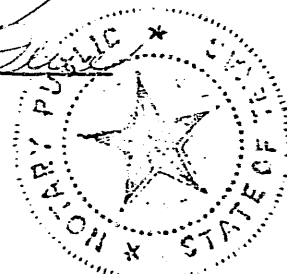
