This Indenture made this 11th day of April 1912 between John E. Pugh and Ella Pugh his wife, the parties of the first part and Frank A. Wachter the party of the second part Witnesseth: That the said parties of the first part for and in consideration of the sum of three hundred fifty dollars gold coin of the United States to them in hand paid by the said party of the second part the receipt whereof is hereby acknowledged do by these presents grant, bargain, sell convey and confirm unto the said party of the second part and to his heirs and assigns the following described piece or parcel of land lying being and situate in the County of Skamania State of Washington to-wit: All of Block eight (8) in the Town of Stevenson according to official plat thereof of record and file in the office of the County Auditor for Skamania County Washington. Together with and singular the tenements hereditaments and appurtenances thereunto belonging or in anywise appertaining. This conveyance is intended as a mortgage to secure the payment of the sum of three hundred fifty dollars gold coin of the United States together with interest thereon on like gold coin at the rate of seven per cent per annum from date until paid according to the terms of one certain promissory note bearing even date herewith made by John E. Pugh and Mrs. Ella Pugh payable two years after date to the order of Frank A. Wachter, and these presents shall be void if such payment be made according to the terms and conditions thereof. But in case default shall be made in the payment of the principal or interest of said promissory note or any part thereof when the same shall be due and payable according to the terms and conditions thereof, then the said party of the second part
