RELEASE OF CONFIRMATORY MORTGAGE.

This Indenture made this 12th day of April, A.D., 1912, by and between the MISSISSIPPI VALLEY TRUST COMPANY, (a Missouri Corporation having its principal office and place of business in the City of St. Louis, Missouri), party of the first part, and the BLAZIER TIMBER COMPANY, (an Oregon corporation having its principal office and place of business in the City of Portland, Oregon), party of the second part, WITNESSETH:

WHEREAS, under date of January 26th, A.D., 1912, said Blazier Timber Company did make, execute, acknowledge and deliver to the party of the first part as Trustee a confirmatory mortgage or deed of trust, covering certain timber lands therein described and acquired by said Blazier Timber Company subsequent to the execution and delivery of original mortgage or deed of trust dated January 30th, 1911, made by Blazier Company and others and recorded in Book "K" of Mortgages, at page 139, in office of County Auditor of Skamania County, Washington, and securing issue of collateral trust notes therein described, amounting to \$250,000;

and WHEREAS, under said confirmatory mortgage dated January 26th, 1912, the property therein described, and acquired by said Blazier Timber Company after the execution of said original mortgage recorded in Book "K" of Mortgages, at page 139 in the records aforesaid, was brought within the terms of and subject to the provisions, conditions and liens of said original mortgage, dated January 30th, 1911; and

WHEREAS, all of said collateral trust notes, aggregating the sum of \$250,000 as aforesaid, together with all interest coupons thereto belonging, have been satisfied and surrendered and cancelled, and by reason thereof said Blazier Timber Company is entitled to a release also of said confirmatory mortgage, dated January 26th, 1912, and recorded as aforesaid:

NOW, THEREFORE, in consideration of the premises and of the sum of one dollar paid to the said party of the first part by the said party of the second part, the said party of the first part does hereby remise, release, convey and quit-claim
