Haynes, the party of the first part for and in consideration of the sum of twenty six hundred two & 8/100 dollars gold coin of the United States of America to him in hand paid by Eliza Davidson, the party of the second part, the receipt of which is hereby acknowledged has granted bargained sold assigned and set over and by these presents does grant bargain sell assign transfer and set over unto the said party of the second part a certain Indenture of Mortgage bearing date the 27th day of May 1909 made and executed by F.W. Ariss & Isabelle D Ariss to the said parties of the first part to secure the payment of the sum of thirty five hundred dollars together with the note or obligation therein described and the money due or to grow due thereon with the interest; which said mortgage was recorded in the office of the recorder of Skamania County Washington in H of Mortgages page 226 on the 30th day of May 1908.
