States Natzel Co. to Natzel

This Indenture made this 18th day of March 1912 between states and Natzel Company a corporation organized and existing under and by virtue of the Laws of the state of Washington, the party of the first part, and William Natzel the party of the second part Witnesseth: That the said party of the first part for and in consideration of the sum of five hundred dollars lawful money of the United States to it in hand paid by the said party of the second part the receipt whereof is hereby acknowledged does by these presents grant, bargain, sell and convey unto the said party of the second part and to his heirs and assigns the following described real property lying and being in the County of Skamania State of Washington to-wit:

Beginning at the SE corner of a tract of land heretofore added by Monroe Vallett to R.W. States and William Natzel deed of which is recorded on page 1908 in Book M of deeds, records of Skamania County Washington reference to which is hereby made, running thence in a westerly direction with an angle of 94 deg thirty nine minutes 162.5 feet, thence in a northerly direction with an angle of eighty five deg. twenty one minutes 268 feet, thence in an easterly direction with an angle of ninety four deg. thirty nine minutes one hundred sixty two and 5/10 feet, thence in a southerly direction with an angle of eighty five deg. twenty one minutes 268 feet to place of beginning containing one acre more or less. Also: Commencing at a point which is north 17 deg 07 minutes west and 342 feet distant from the SE corner of the Monroe Vallett Land in Section 36 Tp. 3 N. R. 7 1/2 East of W.M. thence N 17 deg. 07 minutes
