Smith, the party of the second part the receipt whereof is hereby acknowledged has granted, bargain sold, as assigned transferred and set over and by these presents does grant, bargain, sell assign transfer and set over unto the said party of the second part a certain Indenture of Mortgage bearing date the 27th day of May 1908 made and executed by F.W. Ariss and Isabell D. Ariss to Alma J. Haynes to secure the payment of the sum of thirty five hundred dollars which said mortgage was recorded in the office of the Auditor of Skamania Co.
