I, WALTER D. SAUNDERS, a natural person and a citizen of the State of Washington, being of sound mind and fully aware of the pains and penalties of perjury, do now depose and state the following:

WHEREAS, the State of Washington Driver's License requires a signature with possible contractual implications; and,

WHEREAS, there is no readily available information concerning any possible contractual obligations; and,

WHEREAS, Washington State Statute requires said license to operate a motor vehicle upon the public thoroughfares; and,

WHEREAS, Affiant feels compelled under implied threat of statutory reprisals should he fail to obtain and maintain said license; and,

WHEREAS, one cannot be compelled to seek a privilege that is possessed by Right; and,

WHEREAS, the right to travel is one of the inherited

and inalienable Rights which government was instituted to protect; and,

WHEREAS, a natural person cannot be compelled to waive a Right; and,

WHEREAS, the State of Washington has the power to compel the demonstration of proof, there is no power of compulsion, nor can there be, to accept the terms of a contract; and,

WHEREAS, Affiant knows of only three (3) lawful purposes for which a license need be obtained and they are:

1. Permission to do something which would otherwise be illegal.
2. A grant to the use of property in which one possesses no estate.
3. Certification that a predetermined level of proficiency has been demonstrated.

THEREFORE, let it be known that I, Walter D. Saunders, do, pursuant to RCW 62A.3 401 and 402 declare my intent and qualify my signatures and each and every one of them in possession of the State of Washington Department of Licensing on all documents in their possession and each and every one of them, with the following understanding and/or qualifications:

1. That this Affidavit is to be an integral part of my signatures and for all signatures.
2. To show proof of my having demonstrated the necessary level of proficiency to operate a motor vehicle

safely.

3. That all Driver's licenses and applications for same are not a waiver of any Right or incorporeal hereditament.
4. I am not voluntarily submitting to "Administrative Law".
5. My signatures and all of them are for identification only and are not to be considered as agreeing to any type of contract (express or implied).
6. My signature on all previous Washington Driver's Licenses and applications for same are hereby rescinded and made void without this Affidavit attached.
7. All previous Washington Driver's Licenses issued to me were applied for under mistake and/or ignorance of fact as I was not in possession of all the true material facts surrounding the signing of said licenses.

ALSO:

WHEREAS, Affiant knows of no source of proper authority which would permit his signatures to be used for any other purpose than his declared intent; and,

WHEREAS, terms obligations and/or duties of such use are vague, unrevealed and/or not communicated in full to satisfy informed consent; and,

WHEREAS, Affiant objects to not being able to meet his duty of tendering "payment" for said license as he is able only to discharge with a "tender for debt";

THEREFORE, I, Walter D. Saunders, believe that any law, order, rule or regulation which would prevent this Affidavit from being an integral part of my signatures on

all documents in possession of the State of Washington, Department of Licensing, to be an impairment of my First Amendment Right to speech; an impairment of my Right to avoid voluntary submission to administrative law; and,

Saunders, do hereby submit this Affidavit this 14 day of August, 1984, as an integral part of my signatures on my State of Washington Driver's License and each and every document in possession of State of Washington, Department of Licensing or their agent to prevent said impairments of Rights.
