Beginning at a point thirty feet east and one hundred forty two rods and seven feet north of the southwest corner of the Northwest quarter of the Southwest quarter of section twenty-one Township three north of Range eight east Willamette Meridian, thence running east seventy seven rods and three and one half feet, thence north forty rods and twelve and one half feet, thence west seventy seven <sup>rods</sup> and three and one half feet, thence south forty rods and twelve and one half feet to beginning point containing nineteen and one half acres more or less. The grantee is further granted for road privileges only the unobstructed right to a strip of land thirty feet wide lying next west of the above described land and continuing south to County Road.
