The access port shall be maintained at all times on the well (s).

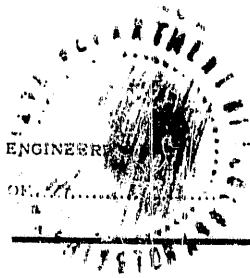
