Know all men by these presents, That we, William Mortensen and Mattie Mortensen, husband and wife
in consideration of One dollar and other valuable considerations to us paid by Oregon Lumber
Company, a corporation organized and existing under the laws of the State of Utah, do hereby
grant, bargain, sell and convey unto said Oregon Lumber Company, a corporation, its successors
and assigns, all the following bounded and described real estate, situated in the County of
Skamania, State of Washington, to-wit:

The Northwest quarter of the Southwest quarter and the Southwest quarter of the Northwest
quarter in Section Fifteen (15) Township three (3) North of Range Nine (9) East of the
Willamette Meridian, containing eighty (80) Acres.

Together with all and singular the tenements, hereditaments and appurtenances thereunto
belonging or in any wise appertaining, and also all timber estate, right, title and interest in
and to the same, including dower and claim of dower. To have and to hold the same unto the
said Oregon Lumber Company, its successors and assigns forever. And we, William Mortensen
and Mattie Mortensen, husband and wife, grantors above named, do covenant to and with the above
named grantee its successors and assigns, that the above granted premises are free from all
incumbrances and that we will and our heirs, executors and administrators shall warrant and
forever defend the same against the lawful claims and demands of all persons whomsoever.
