Together with all the dips, spurs and angles, and also all the metals, ores, gold and silver bearing quartz-rock and earth therein; and all the rights, privileges and franchises thereto incident, appendant and appurtenant or therewith usually had and enjoyed; and, also, all and singular the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, and the rents, issues and profits thereof; and, also, all the estate, right, title, interest, property, possession, claim and demand whatsoever, as well in law as in equity, of the said party of the first part, of, in or to the said premises, and every part and parcel thereof, with the appurtenances To Have and to Hold, all and singular, the said premises, together with the appurtenances and privileges thereunto incident, unto the said party of the second part, their heirs and assigns forever.
