- 55. Also that certain portion of said section fourteen (14), in township one (1) south of range four (4) east of the Willamette Meridian, bounded by beginning at a point one thousand four hundred and seventy-four (1474) feet north of the quarter section corner between sections thirteen (13) and fourteen (14) in township one (1) south of range four (4) east of the Willamette Meridian and two hundred and six (206) feet west of the line between said sections; thence running south eighty-one (81) degrees twenty (20) minutes west, seven hundred and ninety-two (792) feet to a point; thence north eight (8) degrees forty (40) minutes west, two hundred and seventy-five (275) feet to a point, and thence north eighty-one degrees twenty (20) minutes east, seven hundred and ninety-two (792) feet to a point; and thence south eight (8) degrees forty (40) minutes east, two hundred and seventy-five (275) feet to the place of beginning, containing five (5) acres of land;
- 56. Also the right of way for the construction and maintenance of ditches, flumes, water pipes and roads across that certain part of the northeast quarter of section fourteen (14) of township one (1) south of range four (4) east of the Willamette Meridian, formerly owned by Frank Thompson, of the County of Multnomah in the State of Oregon, and the right at all times freely to pass and repass on foot, with horses, cattle, beasts of burden, wagons carts, sleighs or other vehicles whatsoever, from the highway to the above-described five (5) acre tract of land in said section fourteen (14) of township one (1) south of range four (4) east of the Willamette Meridian.
- 57. Also the north half of the northeast quarter of section twenty-three of township one (1) north of range four (4) east of the Willamette Meridian;

Also all of the following described real property, situated in the County of Clarke, in the State of Washington, to wit:

- 58. All of block numbered sixty-six (66) in Vancouver Heights, reference being had to the recorded map or plat of said Vancouver Heights;
- 59. Also all of lots numbered 3 and 4 in block numbered 1 west of Main and A streets in said City of Vancouver, as platted by Esther Short, deceased, above high water line of the Columbia River, including all shore, riparian and literal rights appertaining thereto;
- 60. Also all of the estate, right, title and interest of the Railway Company in and to, and all of its right to occupy, possess and use the following described parcel of real property in the City of Vancouver, to wit:
