Also the following described real property, rights, easements and privileges situated in the County of Skamania in the State of Washington, being part of the said water power properties and rights of the Railway Company mentioned in this indenture, to wit:

64. The southwest quarter of the southeast quarter of section fourteen (14); and

65. Also the northwest quarter of the northeast quarter of section twenty-three (23); and
