And also all those certain lines of railway and street railway situated in the City of Portland in the county of Multnomah in the State of Oregon and in the suburbs of said City and the surrounding country in said County of Multnomah, part thereof being double track lines of railway and part thereof single track lines of railway, laid down and situated upon the following named streets in said City of Portland, and highways, lines and routes, to wit:
