

street; and upon First street from Jefferson street to Porter street, and upon Porter street from First street to Front street, and upon Jefferson street from Fifth street to the western end of Jefferson street and thence continuing westerly to the City Park, and upon Chapman street from Jefferson street to Mill street, and upon Chapman street from Spring street to Elizabeth street; and upon Spring street from Chapman street to Twentieth street, and upon Ford street from Washington street to the south line of Jefferson street, and thence continuing to that certain street located between block numbered fifty-six (56) and block numbered fifty-nine (59) in Carter's addition to said City of Portland, and thence upon said last mentioned street from a point opposite the west line of lot numbered twenty-four (24) in said block numbered fifty-six (56) to the street or highway known as Market Street Drive, and upon said Market Street Drive from said street between said blocks numbered fifty-six (56) and fifty-nine (59) to the street or highway known as Terrace Road, and thence upon said Terrace Road to the connection of the same with Twentieth street, and thence upon Twentieth street to a point seventy (70) feet south of the south line of Spring street, and thence southerly, westerly, southwesterly, westerly, southwesterly and southerly or southeasterly along Terrace Road between Portland Heights, Lent's Addition and Smith's Addition on the one side, and Grover's Addition, Raven's View and the lands of Isabella M.A. Barnes on the other side, to the Patton Road, and thence easterly on, along, or near the Patton Road to Raven's View Drive in Raven's View, and thence along said Raven's View Drive to Terrace Drive, and thence upon Terrace Drive to Elizabeth street, and upon Elizabeth street from Terrace Drive to Chapman street; and beginning at a point near the intersection of the Terrace and Patton Roads, thence in a southwesterly direction across the Patton Road through the land of W.J. Patton, Greenway, Blocks J to P, the land of Tyler Woodward and W.K. Smith et al, to the Talbot Road; thence westerly, southwesterly, southeasterly, easterly, northeasterly and northwesterly around the hill known as Council Crest along the Talbot Road over the land of W.K. Smith et al, Multnomah County, the Thompson, Leonard and Green Estate, Council Crest Park, V. Cook and W.K. Smith, et al, to a point connecting with the line at the Talbot Road. And upon Twenty-fourth street from Savier Street to Nicolai street, and upon Burnside street from Sixteenth street to the Willamette River, and upon East Burnside street from the Willamette river to East Tenth street, and upon Union Avenue from East Burnside street to the north end of Union Avenue; and beginning at a point in the north end of Union Avenue; thence on a prolongation of Union Avenue through the Love Donation Land Claim northerly to a point in the north boundary of the Love Donation Land Claim; thence northerly and northwesterly through the land of Tomasini, G.W. Force, Theo. Nelson Force, Lewis Love, John Bain and Eugenia Henry to the Oregon Slough; thence across the Oregon Slough to Hayden or Shaw's Island; thence across same to the southern shore of the Columbia River. And upon East Tenth street from East Burnside street to East Pine street, and upon East Pine street from East Tenth street to East Eighteenth street, and upon East Eighteenth street from East Pine street to East Stark street; and upon Broadway street from Union Avenue to East Nineteenth street, and upon East Nineteenth street from Broadway street to Halsey street, and upon Halsey street from East Nineteenth street to East Twenty-second street; and upon Russell street from Union Avenue to Gantenbein Avenue, and upon Gantenbein Avenue from Russell street to Monroe street, and upon Monroe street from Gantenbein Avenue to Commercial street, and upon Commercial street from Monroe street to Shaver street, and upon Shaver street from Commercial street to Maryland Avenue, and that certain other line of railway beginning at a point in Union Avenue in said City of Portland, at or near the northeast corner of the southeast quarter of section fifteen (15) of township one north of range one east of the Willamette Meridian, and running thence a short distance in a northeasterly direction, and thence north along the east line of the Lewis Love donation land claim to a point at or near the northeast corner of said Love donation land claim, and thence northwesterly and to a point near the north boundary line of the John Switzler donation land claim, and thence
