and assigns, the right to construct, acquire and own, and to maintain, operate and userrail-ways and poles and wires and underground conduits, cables and conductors in the City of Portland, Oregon,' " and all of the rights, privileges, franchises and immunities granted to or conferred upon said Portland Railway Company, its successors and assigns by said Ordinance No.13178;

Also Ordinance No.13435 of said City of Portland, passed by the Council of said City July 1, 1903, and approved July 2, 1903, entitled "An Ordinance authorizing and consenting to a change in the location of the bridge across Jefferson Street canyon, authorized by Ordinance No.13089 to be constructed, maintained, operated and used by Portland Railway Company, its successors and assigns", and all rights, privileges, franchises and immunities, granted to or conferred upon said Portland Railway Company, its successors and assigns, by said Ordinance No.13435 or by said Ordinance No.13089 as amended by said Ordinance No.13435;

Also Ordinance No.13177 of said City of Portland, passed by the Common Council of said City, January 9, 1903, and approved by the Mayor of said City January 13, 1903, and approved by the Board of Public Works of said City January 14, 1903, entitled "An ordinance, granting to City and Suburban Railway Company, its successors and assigns, the right to construct acquire and own, and to maintain and use railways and poles and wired and underground conduits, cables and conductors in the city of Portland, Oregon", and all rights, privileges, franchises and immunities granted to or conferred upon said City and Suburban Railway Company, its successors and assigns, by said Ordinance No.13177;
