Hansen, city of Portland State of Oregon, party of the second part Witnesseth: That the said parties of the first part for and in consideration of the sum of fourteen hundred (\$1400.00) dollars to them in hand paid, the receipt whereof is hereby acknowledged, have bargained and so Affand by these presents do grantmbargain, sell and convey unto the said party of these econd part his heirs and assigns forever all the following described and bounded property to-wit:

Commencing at the SE corner of Martin Feeney's 1 section, same being the 1 corner on the east line of the SW1 of section 7 T.1 N.R.5 E.W.M., thence north 2481 feet to center of creek; thence following the center of creek in a southwesterly direction to the intersection with the south line of place, thence east 2496 feet to the place of beginning containing 71 acres more or less in Skamania County Washington. Together with the tenements heredtaments and appurtenances thereanto belonging and in anywise appertaining, and also all the estate right title and interest of the sai parties of the first part of, in and to the same. Interest to be paid semigannually and if not so paid the whole sum of both principal and interest to become immediately due and collectible at the option of the holder of this note. And in case suit or action is instituted to collect this note or any portion thereof I promise and agree to pay in addition to the costs and dispursments provided by statute such additional sum as the court may adjudge reso able as attorneys fees to be allowed in said suit or action.

And the said parties of the first part do covenant and agree to pay the said party of the second part his heirs or assigns the said sum of money as above mentioned.
