second part, does hereby transfer, assign and set over unto the said party of  
the second part a certain indenture of mortgage bearing date the 24th day of  
February 1912, made and executed by B.W.Ariss, Anna Ariss, his wife, and H.J.  
Friedrich a single man parties of the first part therein to Cornelia Stuart,  
party of the second part therein, and recorded March 27th. 1912, in Book K
