shall execute any and all documents required in connection with such proceedings, but if CPTIONEE requests OPTIONORS to discontinue said proceedings or if this option shall be terminated before such patent shall issue, OPTIONEE shall be under no further obligation with respect thereto except to pay with respect to such patenting proceedings all charges accrued prior to such request to discontinue or such termination.

During the subsistance of this option, OPTIONEE, its authorized agents, employees, contractors, and representatives shall have the exclusive right to enter into and upon the land covered by the Mining Claims and to conduct thereon, to the extent and at such locations as it shall deem desirable, prospecting, exploring, developing, and mining operations and to place thereon any equipment, structures, or other facilities which it may desire and to remove the same at any time within one hundred eighty (130) days after termination of this option.
