25. Also All of Block numbered Seven (7) in the Town of Bolton, Oregon, according to the duly recorded plat thereof.

26. Also All that portion of the Archibald Eckinley Donation Land Claim in Township Two (2), South of Range Two (2) East of the Villamette Meridian included in that portion of what is known and platted as Block Twenty-one (21) of the Town of Canemah described as follows:

All that portion of said Block Twenty-one (21) which lies north of the South line of the said Archibald Eckinley Donation Land Claim and East of a line described as beginning at a point in the line between the Donation Land Claims of Archibald Eckinley and Absolom F.
