Taffe at the office of the Butler Banking Company, Hood River, Oregon Three Thousand (3000) Dollars in Gold Coin of United States of America, of the present standard value, with interest thereon in like Gold Coin at the rate of 8 per cent. per annum from date until paid, for value received. Interest to be paid Semi-annually. And if not so paid, the whole sum of both Principal and Interest to become immediately due and collectible at the option of the holder And in case suit or action is instituted to collect this note or any portion thereof, I, we or either of us promise and agree to pay, in addition to the costs and disbursements provided by statute, such additional sum in like Gold Coin, as the court may adjudge reasonable for attorney's fees to be allowed in said suit or action.
