(12) and the Southwest quarter of Section number Twelve (12), all in Township

Four (4) South of Range Four (4) East of the Willamette Scridian, containing two
hundred eighty (280) acres.

32. Also All that certain tract of land described as follows:-

Beginning at the Northwest corner of Lot Nine (9) of Cool Ridge Home Tracts, in Section Thirty-six (36), Township One (1) South, Range Three (3) East.

Willamette Meridian, said point being also located in the Fact side line of the right-of-way of the rail-way of the Mortgager Company; thence East along the North side line of said Lot Nine (9) to a point which is Two Hundred (200) feet distent from, meneured at right angles to, the Easterly side line of the said right of way; thence in a Southeasterly direction on a line parallel to and Two Eundred (200) feet distant from said Easterly side line of said right-of-way to a point in the East side line of said Lot Nine (9); thence South along the East side line of said Lot Nine (9) to the Southeast corner of said Lot; which point is also located in the Easterly side line of said right-of-way; thence in a Northwesterly direction, tracing the said Easterly side line of said right-of-way to the place of beginning.
