has 5 located and do hereby locate 1500 linear feet in length, and 600 feet in width on the CAVE CR. MINE

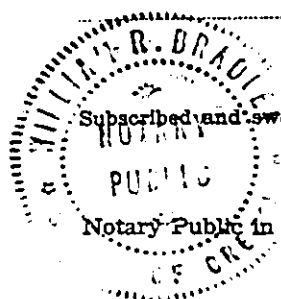
