IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the claimants County of Skamania, Frank Warren and Anna Warren, and each of them, have and recover from the petitioner, Portland and Seattle Railway Company, the sum of one dollar (\$1.00) for the taking and injuriously affecting said land, real estate and premises situated in said Chenowith donation land claim.

It further appearing that there has been paid by the Portland and Seattle Railway Company to the clerk of the court above named the amounts hereinbefore awarded for the benefit of said respective claimants;

IT IS ORDERED, ADJUDGED AND DECREED that all the title held by said claimants in and to said premises be and the same is hereby vested in said corporation, Portland and Seattle Railway Company, for its corporate purposes.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the court hereby retains jurisdiction of of this cause insofar as it relates to lands and premises situated in the Finley donation land claim, described in the petition herein, for the purpose of entering such orders and decrees herein with respect to said premises as may be proper.
