Prindle, his wife parties of the first part, for and in consideration of the sum of Ten Dollars in lawful money of the United States of America and other considerations to them in hand paid by George F. Breslin, party of the second part, have Granted, Bargained and Sold and by these presents do Grant, Bargain, Sell and Convey unto the said party of the second part, and to his heirs and assigns, the following described real property, situate, lying and being in the County of Skamania State of Washington, to-wit: Lot One (1), Block A, of the Town of Prindle, as shown on the plat of said town now on file in the office of the Auditor of said County.

As a part consideration, evidenced by the delivery and acceptance of this deed, it is mutually agreed between the parties hereto as follows: that no vinous, malt, fermented or distilled liquor, or intoxicating drinks of any kind shall ever be manufactured, sold, or offered for sale upon the said land by any person, or persons, with or without license for the sale of liquor under the laws of Washington.

To Have and to Hold, the said premises, with all their appurtenances, unto the said party of the second part, and to his heirs and assigns forever; and the said E.H. Prindle and F.C. Prindle, his wife, parties of the first part, for themselves and for their heirs, executors and administrators, do hereby covenant to and with the said party of the second part their heirs and assigns, that they are the owners in fee simple of said premises, and that they are free from all encumbrances whatsoever, and that they will Warrant and Defend the title thereto against all lawful claims whatsoever.
