R. 6 E., thence in an easterly direction 1413 and $\frac{7}{10}$ feet to an intersection with the Vancouver Wagon Road, being a road 60 feet wide, 30 feet either side of center together with all and singular the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining and also all our right title and interest in and to the same including dower and claim of dower.
