This diagram explains method of description of claim.

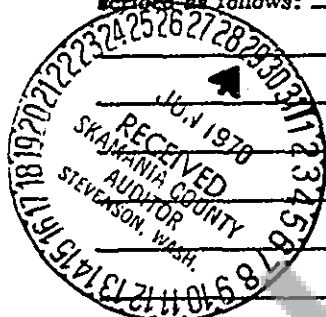
NOTICE IS HEREBY GIVEN, That the undersigned, having complied with the requirements of Chapter Six, Title thirty-two of the Revised Statutes of the United States, and the laws of the above State, and the local customs and regulations of said district,

has located and do hereby locate 1,500 linear feet in length,and 600 feet in width on the Mann Butte Lode

Lode, vein, ledge or deposit (or placer ground), situated in above State, County or Mining District, and further described as follows: Commencing at a post marked No. 1 at the Discovery Shaft (cut or tunnel), from thence

300 feet in a Southerlydirection to an end post marked No. 2, thence 300 feet in a Westerlydirection to a corner post marked No. 3, thence 1,500 feet in a Northerlydirection to a corner post marked No. 4, thence 600 feet in a Easterlydirection to a corner post marked No. 5, thence 1,500 feet in a Southerlydirection to a corner post marked No. 6, thence 300 feet in a Westerlydirection to said end post No. 2; hereby locating and intending to claim 300feet in a Southerly direction from discovery to the Southend line, and 1,200 feet in the opposite direction from discovery to theNorth end line, and 300 feet on each side of the middle of said lode or ledge, for the purpose of mining the same and claiming all surface rights, privileges and minerals, with all dips, spurs, angles and variations, and other rights granted by existing laws and customs. This claim is further described as follows:

This is the Mann Butte Mining Claim No. 52. The south end line of this claim joins onto the north end line of the Mann Butte Mining Claim No. 41, and the east side of this claim joins onto the west side of the Mann Butte Mining Claim No. 51.
