(a) Also All those certain parcels of land conveyed by the Portland Rail-way, light and Power Company to the Public by deed dated July 19, 1909, matifying and confirming the dedication to the public as streets of the said parcels of land, which are particularly described as follows:-

First: Beginning at a Point where the northerly boundary line of the William Caples Donation Land Claim intersects the Easterly boundary line of the City of St. Johns, County of Eultnomah and State of Oregon; running thence in a southerly direction along said easterly boundary line of said City of St. Johns to a point where said easterly boundary line intersects the northerly boundary line of Block F in East St. Johns (reference being had herein to the established and recorded map and plat of said "Bast St. Johns, Blocks A,B,C,D,E,F,C,H,J,K,L,M,N,O,P,Q,R, and 3"); thence in an easterly direction along said northerly boundary line of said Block F to the westerly side line of a tract of land owned by the Estate of Vm. Praisher; thence in a northerly direction to a point in the northerly boundary line of the William Caples Donation Land Claim, which said point is situated One Thousand and Twenty-six One-Hundredths (1000.26) feet along said northerly boundary line of said William Caples Donation Land Claim in a westerly direction from the northeast corner of said claim; thence in a westerly direction from the northerly boundary line of said claim; thence in a westerly direction from the northerly boundary line of said claim to the place of beginning.

Second: Beginning at a point on the northerly boundary line of the William Caples Donation Land Claim, which said point is situated four bundred seventy and thirteen one-hundredths (470.13) feet along said northerly boundary line of said William Caples Donation Land Claim in a westerly direction from the northeast corner of said claim; running thence in a westerly direction along the northerly boundary line of said claim a distance of sixty (60) feet; thence in a southerly direction and parallel with the easterly boundary line of said William Caples Donation Land Claim a distance of Twenty (20) feet; thence in an Easterly direction and parallel with the northerly boundary line of said claim a distance of Sixty (60) feet; thence in a northerly direction a distance of twenty (20) feet to the place of beginning.

Excepting and reserving, however, from the two said lots or parcels of land described in this Sub-division (8), the exclusive right-of-way for railway, street railway and electrical purposes over, upon, across and along the same in favor of the Hortgagor Company and subject to which the said two lots or parcels of land have been or are to be dedicated to the public as streets, and which right-of-way it is intended shall be subjected to the lien of this Indenture.

The following described properties, rights, privileges and franchises are also included in the properties conveyed by this Indenture:-

- 37. That certain steam ferry boat or vessel called the "City of Vancouver" of the burden of 460 tons or thereabouts, together with her boilers, engines, masts, bowsprits, boats, anchors, cables, chains, rigging, tackle, apparel, furniture and all the other appurtenances thereunto belonging or in anywise appertaining.
- 38. Also All the rights, privileges, licenses, franchises and immunities granted to and conferred upon J.L. Hartman and John W. Cook, their heirs, personal representatives and assigns by those certain orders and decrees of the County Court of Multnomah County, dated February 28th, 1907, March 13th, 1907, September 25th, 1907, and June 23, 1908, the said orders and decrees having been by Hartman and Cook
