Devold of portland, oregon party of the second art Witnesseth: That the said party of the first part for and i consideration of the sum of two thousand and five hundred dollars lawful money of the United states to him in hand paid by the said party of the second part the receipt whereof is hereby acknowledged does by these presents grant bargain sell and convey unto the said party of the second part ad to his heirs and assigns the following described tract or parcel of land lying and being i the County of Skamania State of Washington and partirularly described as follows to-wit: The North half of the Southeast Quarter and the south half of the Northeast quarter of section nineteen (19) and the south half of the northwest quarter and the north half of the Southwest quarter of Section twenty (20) all in Township two (2) North of Range five (5) East of W.M. together with all and simular the tenements hereditaments and appurtenances thereunte belo nging This conveyance is intended as a mortgage to secure the payment of the sum of two thousand five hundred dollars lawful money of the united states together withhinterst there on at the rate of eight per cent per annum from date antil paid according to the terms and conditions of a certain promissory note bearing date September 14th 1912 made and executed by said John J. Kuntz payable two years after date to the order of N.J.Devold and these presents shall be void if such payment shall be made according to the agreements thereof. In any suit or other proceedings which may be had for the recovery of the amount due upon said note or this mortgage, said party of the second part his h eirs or assigns shall have the right to have included in the judgment Which may be recovered the sum as provided in said note as attorneys fees to be taxed as part of the costs in such suit as well as all payments which the said party of the second part hi s heirs or assigns may be obliged to make for his or their security by insurance or on account of any taxes charges incum brances or other assessment's whatseever on the said premisesor any part thereof. In case of foreclsure of this mortgage the party of the second part his heirs or assigns shall be entitled to have entered in such forec esrue's it a judgements for any deficiency upon account of the i ndebtedness secur ded hereby including taxes assessments or other lawful assessemtns after applying the proceeds of the sale of said premises to the payment thereof and to the costs efesuch foerclosrure suit.
