John Blomstrom to McCoy Creek Mines Company.

This Indenture, Made the 16th day of January in the year of our Lord one thousand nine hundred and six Between John Blomstrom of Lewis County, State of Washington the party of the first part, and the McCoy Creek Mines Company a corporation organized and existing under the laws of the State of Washington, the party of the second part, Witnesseth: That the said party of the first part, for and in consideration of the sum of One Dollar money of the United States of America, to him in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, have granted, bargained, sold, remised, released and forever quitclaimed, and by these presents does grant, bargain, sell, remise, release and forever quitclaim unto the said party of the second part, and to its successors and assigns the following mining claim, towit: "Gold Eagle Mine" located the 16th day of August, 1905, situated about 1500 feet North of Camp Creek and about $\frac{1}{2}$ mile East of the McCoy Creek in Skamania County, State of Washington, filed for record in the office of the County Auditor of Skamania County, Washington, Sept. 5, 1905, and recorded in Book C of Mineral Locations, Page 356, records of said Skamania County. Together with all the dips, spurs and angles, and also all the metals, ores, gold and silver bearing quartz, rock and earth therein; and all the rights, privileges and franchises thereto incident, appendant and appurtenant, or therewith usually had and enjoyed; and, also, all and singular the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, and the rents, issues
