East half of Northwest quarter of Section twenty-five, Township three North of Range eight East of Willamette Meridian, containing eighty acres, together with all and singular the tenements hereditaments and appurtenances thereunto belonging or in any wise appertaining and all of my right, title and interest claim, possession and demand of any kind wether at law or equity of, in or to the above described premises. To have and to hold the same unto the said Ole Thompson and to his heirs and assigns forever. And the said Styrk Flatebo does hereby covenant to and with the said grantee his heirs and assigns that at the date hereof he was well seized in fee simple of the premises above conveyed and that he will and his heirs, executors and administrators shall warrant and defend the title to same against all lawful claims and demands whatsoever.
