approved May 10, 1872, and all subsequent Acts, and with local customs, laws and regulations, CLAIM'S 1,320" BY 660' linear feet and horizontal measurement on the COPPER, SILVER, & OTHER MINERALS lode, vein, ledge or deposit along the vein thereof, with all its dips,

angles and variations, as allowed by law, together with 1,320 feet & 330 <sup>LOW EACH</sup> ~~CONNECTION~~

side and 1,320 <sup>DUE SOUTH</sup> feet on the EAST & WEST <sup>SIDES</sup> side of the middle of said vein at the surface, so far as can be determined from present developments; and all veins,

BEGINNING at Cor. No. 1 (the EAST <sup>OR NE</sup> corner), running thence WESTERLY feet 330 FT, to a post marked CENTERLINE; thence 330 FT feet WESTERLY, to a post marked NW COR WEST corner (Cor. No. 2); thence DUE SOUTH feet 1,320 FT, to a post marked SW corner (Cor. No. 3); thence 330 FT feet EASTERLY, to a post marked CENTERLINE SOUTH; thence DUE EAST feet 330 FT, to a post marked SE corner (Cor. No. 4); thence DUE NORTH feet 1,320 FT to a post marked EAST COR NE corner, the place beginning.
