Know all men by these presents that Josiah M. Iman, a single man, of Stevenson Skamania County Washington, for and in consideration of the sum of fifty six hundred and fifty dollars to him in hand paid by Frederick A. Kribs of Portland Oregon, the receipt whereof is hereby acknowledged has granted, bargained and sold and by these presents does grant, bargain, sell, convey and confirm unto the said Frederick A. Kribs and to his heirs and assigns forever an undivided seven eighths (7/8) of all those tracts of land lying and being in the County of Skamania, State of Washington and particularly described as follows, to-wit:
