and the southwest quarter of section twenty-eight (28) in township six (6) north of range four (4) east of the Willamette Meridian, containing three hundred and twenty (320) acres, according to the government survey, but subject, however, to such rights, if any exist, acquired by Portland, Vancouver, & Yakima Railway Company, or its successors, under a contract for conveyance with O.F.Shintaffer, dated January 7, 1899, recorded in Book 44, at pages 91 and 92, of the Records of Clarke County, Washington.

It is understood and agreed, however, that all covenants of every nature, either express or implied, and whether arising by statutory implication or otherwise, or expressed in this indenture, are hereby expressly excluded from the operation of this indenture as relates to that part of the northwest quarter of the southwest quarter of said section which lies in Cowlitz County, Washington, but shall apply with full force and effect as to the remainder or balance of said hands.
