## McClure to Strong

This Indenture made this 27th day of November 1908 between C.W.McClure and Daisy McClure husband and wife of Mt Pleasant Skamania County Washington,party of the first part and J.F. Strong of said Mt.Pleasant party of the second part,Witnesseth that the said party of the first part for and in consideration of the sum of Four thousand (\$4000.00) Dollars lawful money of the United States of America to them in hand paid by the said party of the second part,do by these presents grant,bargain,sell convey and confirm unto the said party of the second part,his heirs executors administrators and assigns,the following described real estate lying and being in the County of Skamania State of Washington described as follows to-wit:

The Southeast quarter (SE $\frac{1}{4}$ ) of the Northwest quarter (NW $\frac{1}{4}$ ) of Section seventeen (17) in Township One (1) North of Range five (5) East of the Willamette Meridian,containing forty (40) acres.

With all and singular the tenements hereditaments and appurtenances to the same belonging or appertaining ,the reversion or reversions,the remainder or remainders,rents issues and profits thereof.To have and to hold the same unto the said party of the second part,his heirs and assigns forever with the privileges and appurtenances thereunto belonging. And the said party of the first part does covenant for themselves and their heirs,executors and administrators and assigns to and with the said party of the second part his heirs and assigns as follows:

1st. That the said party of the first part are seized in fee simple of said premises and have good right to convey the same. 2nd.That the said party of the second part shall quietly enjoy the said premises.3rd That the said premises are free from all incumbrances.Except a mortgage given by said grantors to James Peterson for \$1600.00 dated May 8th 1907 which said mortgage
