the Counties of Skamania and Klickitat, State of Washington, particularly described as follows:

The undivided one-half of that part of the south half of the north half of the southwest quarter of the northeast quarter of section ten (10), township three (3) north of range ten (10) east of the Willamette Meridian, lying west of a line beginning at a stone in the north line of said tract 834 feet west of the northeast corner thereof, thence south 2 degrees and 9 minutes east 330.6 feet to a stone in the south line of said tract 834.7 feet west of the southeast corner thereof, containing three (3) acres, more or less.

(14) All that certain piece or parcel of land situate, lying and being in the Counties of Skamania and Klickitat (if in both counties), State of Washington, particularly described as follows:

All that part of the southeast quarter of the northwest quarter of section ten (10) in township three (3) north of range ten (10) east of the Willamette Meridian, which lies within two hundred (200) feet of the center line of the White Salmon River.

- (15) All those certain pieces or parcels of land and rights and privileges and easements in lands situate, lying and being within the Counties of Skamania and Klickitat, State of Washington, particularly described as follows:
- (a) The northeast quarter of the northeast quarter of the northwest quarter of section ten (10) in township three (3) north of range ten (10) east of the Willamette Meridian, containing ten (10) acres, more or less.
- (b) All that part of the southeast quarter of the northeast quarter of the northwest quarter of section ten (10) and the northwest quarter of the northeast quarter of said section ten (10), in township three (3) north of range ten (10) east of the Willamette Meridian, which lies westerly of the center line of the White Salmon River and easterly of a line running two hundred (200) feet west of and parallel with the center line of said White Salmon River.
- (c) All that part of the northwest quarter of the northeast quarter and of the southeast quarter of the northeast quarter of the northwest quarter of section ten (10), in township three (3) north of range ten (10) east of the Willamette Meridian, which is bounded and described as follows, viz:

 Beginning at a point in the south line of the northwest quarter of the northeast quarter of said section, 545.6 feet east of the southwest corner of said northwest quarter of the northeast quarter of said section ten (10), and thence running north

quarter of the northeast quarter of said section ten (10), and thence running north twenty-name degrees and 49 minutes west 703.53 feet to a point in the division line between the Kuhne and Cameron tracts; thence west along said division line 212.5 feet to a point in the west line of the northeast quarter of said section ten (10); thence north 1 degree and 41 minutes west along said west line of the northeast quarter of said section, 55 feet to the southeast corner of the northeast quarter of the northwest quarter of the northwest quarter of the northwest quarter of said section, 310 feet, more or less, to a point in the center line of the White Salmon River; thence southeasterly and following the center line of said White Salmon River (down stream) to a point in the south line of the northwest quarter of the northeast quarter of said section 10; thence east along said last named south line, 500 feet, more or less, to the point of beginning, containing 7.77 acres, more or less.

(d) A strip of land 12 feet wide to be used as a private roadway or for other purposes, running from the northeast corner of said 7.77 acre tract above
