

north line of the southeast quarter of the northeast quarter of said section 2, 400 feet to the point of beginning, containing 1.61 acres, more or less.

✓ (36) All that certain piece or parcel of land situate, lying and being in the Counties of Klickitat and Skamania, State of Washington, particularly described as follows:

The West half of the southeast quarter and the southeast quarter of the southwest quarter of section three (3), township three (3) north of range ten (10) east of Willamette Meridian; excepting therefrom that portion conveyed by the Menominee Lumber Company to Theodore Adams by deed filed September 17th, 1906, and recorded in book "T" of deeds, page 409, Klickitat County, Washington, and described as follows: That portion of the west half of the southeast quarter of the said section three (3) lying east of a line running one hundred (100) feet east of and parallel or equi-distant from the edge of the east bank of the White Salmon River where said bank is well defined, said line in no case to exceed three hundred (300) feet from the center of said stream, whether the bank is clearly defined or not.

(37) All that certain piece or parcel of land situate, lying and being in the County of Klickitat, State of Washington, particularly described as follows:

Beginning at the quarter corner between sections 25 and 26 in township 3 north of range 12 east of the Willamette Meridian; thence north along the section line between said sections, 922 feet; thence southwesterly, 990 feet to a point in the mid-section line running east and west in said section 26, 360 feet west of said quarter corner between said sections 25 and 26; thence easterly along said mid-section line in said section 26, 360 feet to the point of beginning; excepting the right of way of the Columbia River and Northern Railway Company as now located across said land; containing 2.52 acres, exclusive of said right of way.

✓ (38) All the rights of Northwestern Electric Company as assignee of Mortimer Fleishhacker in a certain contract between Wind River Lumber Company, a corporation of the State of Wisconsin, and the said Fleishhacker, dated the 22nd day of November, 1911, and executed at Cascade Locks, Oregon, whereby the said Wind River Lumber Company agreed to sell, and the said Fleishhacker agreed to purchase, subject to a certain trust deed executed and delivered by Wind River Lumber Company to Central Trust Company of Illinois and A. Uhrlaub, Trustees, dated April 1, 1910, to secure an issue of first mortgage six per cent. bonds in the total sum of \$300,000, all of the following described rights and properties situated in the Counties of Skamania and Klickitat, State of Washington, to wit:

✓ (a) All of the capital stock of the White Salmon Boom & Improvement Company, and all of the capital stock of the Frost Improvement Company, both being corporations of the State of Washington.

✓ (b) The west half of the southeast quarter and the southeast quarter of the southwest quarter of section three (3), township three (3) north of range ten (10) east of Willamette Meridian; save and except a parcel of approximately thirty (30) acres on the east side of the White Salmon River, to which said Lumber Company has never had or claimed title.

✓ (c) The southwest quarter of the northeast quarter of section 3; the east half of the southeast quarter, and the northwest quarter of the southeast quarter, and the southeast quarter of the northwest quarter of section four (4); the south half of the southeast quarter and the northwest quarter of the southeast quarter of section eight (8); that part of the west half of the southeast quarter of the northwest quarter, and the east half of the southwest quarter of the northwest quarter, and the east half of Lot one (1), and the west half of Lot two (2), of
