Parties of the first part, for and in consideration of the sum of One hundred and fifty Dollars in lawful money of the United States to us in hand paid by H.W. Smith, party of the second part, have granted, bargained and sold and by these present do grant, bargain and sell unto the said H.W. Smith and to his heirs and assigns the following described real property situate lying and being in the County of Skamania, State of Washington, to-wit:

Beginning 20 rods east and 130 feet south of the Northwest corner of the Northwest quarter of the Northeast quarter of Sec. 28 Tp. 3 N of Range 8 East of the W.M., thence running south 134 feet, thence east 165 feet; thence North 264 feet, thence west 115 feet, thence South 130 feet, thence west 50 feet to place of beginning, containing one acre of land less 1 lot 50 x 100 feet heretofore sold to Wm. Cochran. To have and to hold the said premises with all their appurtenances unto the said party of the second part and to his heirs and assigns forever.
