Smith, do hereby bargain, sell and convey unto the said Myron S. Smith, his successors and assigns, the following described premises, situated in the County of Skamania and State of Washington: The East half (E $\frac{1}{2}$ ) of the Northeast quarter (NE $\frac{1}{4}$ ) of the Northwest quarter (NW $\frac{1}{4}$ ) of Section 21 (Sec. 21) Township three North (Tp. 3N), Range ten east (Rg 10 E) of Willamette Meridian, and containing 20 acres more or less. Reserving for road purposes a strip of land ten feet in width along the east line of said tract. And I hereby covenant with the said Myron S. Smith, his successors and assigns that I hold said premises by title in fee simple, that they are free from all liens and incumbrances whatsoever and I covenant to Warrant and Defend the said premises against the lawful claims of all persons whomsoever.
