The Grantor, for and in consideration of the sum of one dollar in hand paid conveys and quitclaims to the Spokane, Portland and Seattle Railway Company, a Washington corporation, its successors and assigns, all his right, title and interest in and to the following described real property situate in the County of Skamania State of Washington, to-wit:

A strip of land two hundred feet in width, being one hundred feet in width upon each side of the center line of the railroad of said railway company as now located and constructed over and across the Donation Land Claim of Daniel Baughman, being known as claim No. 42 and being parts of Sections one, two and eleven in Township two North of Range seven East of Willamette Meridian.
