French the purchaser of said land at said sale, for and in consideration of the sum of Two hundred fifty nine & 10/100 Dollars, Gold Coin of the United States, in hand paid, the receipt whereof is hereby acknowledged, all the right, title or interest said George Udell had of, in or to said lands at and before the time of his death and all the interest his said estate has since acquired by operation of law or otherwise, of, in and to said lands, which said land is situated in Skamania County, in the State of Washington, and is particularly bounded and described as follows:

Commencing at a point 748 feet south and 729 and 5/10 feet east of the quarter corner between section one and thirty six of Tps. 2 and 3 North of Range seven East W.M. said point being the NE corner of Mrs. Elsworth Lot, thence west 50 feet to the North west corner of said Mrs. Elsworth land, thence south 104 feet along west boundary of said lot to the north line of Ash and Attwell's Lot, thence south 89°45' west 200 feet along north line of Ash & Attwell Lot; thence North 259 feet to State Road No.8, thence south 88 degrees 58 minutes East along State Road No.8, 250 feet, thence south to place of beginning.
