Know all men by these presents that Charles Iman of Stevenson, Wash? a single man, in consideration of Three hundred & forty three dollars and 86/100 Dollars to him paid by Frederick A.Kribs of Portland, State of Oregon, has bargained and sold and by these presents do bargain grant and sell and convey unto the said Frederick A.Kribs, his heirs and assigns all the following bounded and described real property situated in the County of Skamania State of Washington, to-wit:
