This Indenture Witnesseth that A.C.Sly and Margaret Sly (his wife) and Raymond C.Sly (a single man) all of Stevenson, Wash, parties of the first part, for and in consideration of the sum of One Dollar and other valuable considerations in lawful money of the United States to them in hand paid, by James H.Sly and Delia Sly of Roscommon, Michigan, parties of the second part, have granted, bargained and sold and by these presents do grant, bargain, sell and convey unto the said parties of the second part and to their heirs and assigns the following described real property situate lying and being in the County of Skamania, State of Washington, to-wit:

Commencing at a point on the west line of the H.Shepard D.L.Claim, said point being situated 15.75 chains east and 20.98 chains north of the One quarter section corner of Sections one and thirty six (1 & 36) Township two and three (2 & 3) North of Range seven East of Willamette Meridian thence East 31.47 chains, thence North 17 degrees 7/100 minutes west 24.52 chains to the North line of the said H.Shepard Donation Land claim; thence westerly along the north line of said H. Shepard Donation Land claim to the Northwest corner of the said H.Shepard D.L.Claim; thence southerly 23.44 chains to the point of beginning.
