All that part of the North side of the Northwest quarter of the Northwest quarter of Sec. six (6) Township three (3) North of Range eight (8) East of Willamette Meridian that lays north of a line running east between the north and south half of the Northeast quarter of Section One (1) Township three North, Range seven and one half (7½) East of Willamette Meridian, containing twenty-five (25) acres more or less.

To have and to hold the above granted premises with all the rights, easements and appurtenances thereto belonging unto the said J.J.Richardson, heirs and assigns forever. And the grantors do covenant to and with the said grantees, heirs and assigns, that they are lawfully seized in fee of the above granted premises, that they are free from all incumbrances, except one mortgage to secure the payment of five hundred and fifty (\$550.00) Dated January 22nd 1908, and that they will and their heirs, executors and administrators shall warrant and defend the above granted premises to the said grantee his heirs and assigns forever against the lawful claims and demands of all persons except as above stated.
