Township twenty eight North Range fourteen West, the west half of the Southwest quarter of section two containing eighty acres and the southeast quarter of the Northeast quarter and Northeast quarter of the southeast quarter of Section three containing eighty acres. Township thirty North Range fourteen West, the southeast quarter of the Southwest quarter and the Southwest quarter of the southeast quarter of Section seven containing eighty acres and the North half of the Northeast quarter of Section eighteen containing eighty acres.
