

two and three of Section twenty in Township two north of Range seven East in the district of Lands subject to sale at Vancouver, Washington Territory, containing fifty two acres and fifty hundredths of an acre, according to the official plat of the survey of the lands, returned to the General Land Office by the Surveyor General, which said Tract has been purchased by the said Philip Ritz: Now Know Ye, that the United States of America, in consideration of the premises and in conformity with the several acts of Congress in such cases made and provided, Have Given and Granted and by these presents do Give and Grant unto the said Philip Ritz and to his heirs, the said tract above described, to have and to hold the same together with all the rights, privileges immunities and appurtenances of whatever nature thereunto belonging, unto the said Philip Ritz and to his heirs and assigns forever.

In Testimony Whereof I, Ulysses S. Grant, President of the United States of America, have caused these letters to be made patent and the seal of the General Land Office to be hereunto affixed. Given under my hand at the city of Washington the tenth day of June in the year of our Lord one thousand eight hundred and seventh and of the Independence of the United States the ninety fourth.

United States to Chenowith

The United States of America To all to whom these presents shall come Greeting:

Francis A. Chenowith and wife.

Whereas there has been deposited in the General Land Office of the United States a certificate numbered one hundred and fifty eight of the Receiver and Register at Vancouver, Washington Territory, whereby it appears that under the provisions of the act of Congress approved the 27th day of September 1850, entitled, "An act to create the office of Surveyor General of the Public Lands in Oregon and to provide for the survey and to make donations to settlers of the said public lands" and the legislation supplemental thereto, the claim of Francis A. Chenowith and his wife Elizabeth A. Chenowith, of Clarke County, Washington Territory, Notification No. 283, has been established to a donation of one section or six hundred and forty acres of land and that the same has been surveyed and designated according to the official plat of survey returned to the General Land Office by the Surveyor General, as Lots one and seven of Section fourteen, the West half of the Southeast quarter, the south half of the Southwest quarter, and Lots one and five of Section fifteen, the South half of the Southeast quarter and lot seven of Section sixteen, the North half of the Northeast quarter and lots three four, five and six of Section twenty-one, and the Northwest quarter of the Northwest quarter and lots one, two and three of Section twenty-two, all in Township two North of Range seven East, in the district of lands subject to sale at Vancouver, Washington Territory, containing six hundred and thirty five acres and fifty-three hundredths of an acre.

Now Know Ye, that the United States of America, in consideration of the premises and in conformity with the provisions of the act aforesaid, have given and granted and by these presents do give and grant unto the said Francis A. Chenowith and to his heirs the East half, and unto his wife, the said Elizabeth A. Chenowith, and to her heirs the West half of the tract of land above described, to have and to hold the said tract with the appurtenances unto the said Francis A. Chenowith and his wife Elizabeth A. Chenowith and to their heirs and assigns forever, their respective portions as aforesaid.
