Know all men by these presents that I, Kate Cusic, a single woman, unmarried, residing at the city of Portland of the County of Multnomah in the state of Oregon for and in consideration of the sum of seven hundred fifty (750) Dollars to me in hand paid by Grace E. Hussey wife of Henry A. Hussey formerly of Haverhill Massachusetts now of the town of Underwood County of Skamania, State of Washington, the receipt whereof is hereby acknowledged have bargained and sold and by these presents do grant, bargain, sell and convey unto the said Grace E. Hussey and unto her heirs and assigns forever all of that certain tract of land lying and being in the County of Skamania State of Washington and particularly described as follows; to-wit:

Beginning at the Northwest corner of the Northeast quarter of the Northeast quarter of Section twenty two (22) in Township three (3) North of Range ten (10) East of Willamette meridian, thence east four hundred forty (440) feet on the north line of section twenty two (22), thence south four hundred ninety-five (495) feet parallel with the east line of section twenty two (22), thence west four hundred forty (440) feet parallel with the north line of section twenty two (22), thence north four hundred ninety-five (495) feet parallel with the east line of section twenty two (22) to the place of beginning containing five (5) acres more or less, being the same property acquired by Kate Cusic from Edmund C.
