Jones, parties of the second part, and to their successor or successors in the trust hereby created, all and singular, the real estate, property, rights and privileges of the Company of whatsoever kind and nature, both now owned and that which may hereafter be acquired, and all of the following described real estate, together with all timber and improvements thereon and personal property situated in the County of Skamania, in the State of Washington:
