

Section 19. East half ($E\frac{1}{2}$), Southeast quarter of Northwest quarter ($SE\frac{1}{4} NW\frac{1}{4}$), Lot Four (4) or (Southwest quarter of Southwest quarter ($SW\frac{1}{4} SW\frac{1}{4}$)).

Section 20. Southeast quarter ($SE\frac{1}{4}$).

Section 21. Lots One (1) Two (2) Three (3) and Four (4) or (East half of East half ($E\frac{1}{2} E\frac{1}{2}$)), West half of East half ($W\frac{1}{2} E\frac{1}{2}$) and West half ($W\frac{1}{2}$).

Section 22. Southeast quarter of Northeast quarter ($SE\frac{1}{4} NE\frac{1}{4}$), Northwest quarter ($NW\frac{1}{4}$), Southeast quarter ($SE\frac{1}{4}$).

Section 23. Northwest quarter of Northwest quarter ($NW\frac{1}{4} NW\frac{1}{4}$) South half of Northwest quarter ($S\frac{1}{2} NW\frac{1}{4}$), North half of Southwest quarter ($N\frac{1}{2} SW\frac{1}{4}$) ~~XXXXXXXXXX~~
~~XXXXXXXXXX~~ and Southwest quarter of Southwest quarter ($SW\frac{1}{4} SW\frac{1}{4}$).

Section 26. West half of West half ($W\frac{1}{2} W\frac{1}{2}$), South half of Southeast quarter ($S\frac{1}{2} SE\frac{1}{4}$) and Northeast quarter of Southeast quarter ($NE\frac{1}{4} SE\frac{1}{4}$).

Section 27. East half of Northeast quarter ($E\frac{1}{2} NE\frac{1}{4}$) and Southwest quarter of Northeast ($SW\frac{1}{4} NE\frac{1}{4}$) Both subject to right-of-way for wagon road. All the timber on the Northwest quarter of Northeast quarter ($NW\frac{1}{4} NE\frac{1}{4}$) excepting the timber on 20 acres within said $NW\frac{1}{4} NE\frac{1}{4}$ in one body to be designated by the grantors, with right-of-way for wagon road across same. Southeast quarter ($SE\frac{1}{4}$).

Section 28. Lots One (1) and Two (2) and the West half of Northeast quarter ($W\frac{1}{2} NE\frac{1}{4}$), Northwest quarter ($NW\frac{1}{4}$), North half of Southwest quarter ($N\frac{1}{2} SW\frac{1}{4}$), Northwest quarter of Southeast quarter ($NW\frac{1}{4} SE\frac{1}{4}$).

Section 29. Northeast quarter ($NE\frac{1}{4}$), West half ($W\frac{1}{2}$), West half of Southeast quarter ($W\frac{1}{2} SE\frac{1}{4}$), Southeast quarter of Southeast quarter ($SE\frac{1}{4} SE\frac{1}{4}$).

Section 30. East half ($E\frac{1}{2}$) East half of West half ($E\frac{1}{2} W\frac{1}{2}$), Lots One (1), Two (2) and Three (3).

Section 31. Northeast quarter ($NE\frac{1}{4}$), East half of Northwest quarter ($E\frac{1}{2} NW\frac{1}{4}$), North half of Southeast quarter ($N\frac{1}{2} SE\frac{1}{4}$).

Section 35. East half of Northwest quarter ($E\frac{1}{2} NW\frac{1}{4}$) West half of Northwest quarter ($W\frac{1}{2} NW\frac{1}{4}$, East half of Southwest quarter ($E\frac{1}{2} SW\frac{1}{4}$), West half of Southeast quarter ($W\frac{1}{2} SE\frac{1}{4}$), West half of Northeast quarter ($W\frac{1}{2} NE\frac{1}{4}$) excepting the loose timber, wife fencing and buildings (except the mess house thereon) cord wood and bricks.

Also all rights, title and interest of the Company in, to, and under a certain contract dated January 27, 1913, and any supplements thereto, between the J.K. LuLumber Company, the Rainier Lumber & Shingle Co., the Hamilton Creek Timber Co. and E.H. Dodge, relating to the cutting of timber on said above described lands, including all rights of the Company to receive payments under said contract, or supplements thereto.

Also all logs, logging plants, equipment and machinery, mills, boilers, engines, power plants, machine shops, flumes, tramways, railroads, railroad ties, rails, equipment, motive power, engines, cars, and other rolling stock, and all houses, buildings, structures, engines, machinery and apparatus of every kind or character, and all saw mills, saws, booms, conveyors, easements and rights of way, situate upon or used in connection with said railway and all the property and rights of the company in and to any or all the property and rights of the company in and to any or all of the land above described and the timber standing thereon, together with all and singular, the rights, tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, and all the reversion and reversions, remainder and remainders, issues, tolls, royalties, rents, income and profits of the Company, it being the true intent of the parties hereto that this instrument shall convey all of the Company's right, title and interest in and to the above described real estate, together with all and singular the buildings, structures, plants, equipment and improvements of every kind
