Know all men by these presents that we, J.T.Reynolds and Minnie Reynolds, husband and wife, of the County of Skamania, State of Washington, for and in consideration of five hundred dollars (\$500.00) to us in hand paid by the Columbia River & Northern Railway Company of Portland, Oregon, as Grantees, the receipt whereof is hereby acknowledged, by these presents do grant, bargain, sell and convey unto the said Columbia River & Northern Railway Company, their successors and assigns, all the following bounded and described real property situated in the County of Skamania State of Washington to-wit: Beginning at a point 20 chains east of Corner of sections 29, 30, 31 & 32 on a true line, thence east on a true line 8 chains and 50 links, thence south to the meander line of the Columbia River, thence in a westerly direction with the meander line of said Columbia River to a point directly south of said point of beginning, thence North to the place of beginning, the same being the Southeast corner of the Southwest quarter of the Southwest quarter of Section 29, Tp.3 N.R.8 E.W.M.; together with all and singular the tenements hereditaments and appurtenances thereunto belonging or in any wise appertaining. To have and to hold the said described and granted premises unto the said the Columbia River & Northern Railway Company their successors and assigns forever.
